CAR/VAN RENTALS: Compact 4-door car with 1 room/unit. 7 passenger minivan, or other car upgrades are available upon request for fee. Cars can only be reserved with actual driver names. Not included: fuel, insurance, parking, additional driver fee, overtime charges, upgrades, child car seat or drop charges. Minimum age of driver is 21. Driver between the ages of 21 to 24 will have an added surcharge per day. Drivers must have a valid driver's license and a major credit card in their names. Late car requests are subject to availability and may have higher rates.

AIRLINES & ACCOMMODATIONS: FAA scheduled airlines or DOT approved charter. TIS reserve the right to substitute carrier as needed. We will provide you with specific information, such as amenities, exact location and features of all the accommodations that we offer. RESERVATIONS, DEPOSITS & FINAL PAYMENTS: A deposit of \$125.00 per person is required for reservations made more than 90 days before departure. \$200.00 deposit per person - less than 90 days to departure. Final payment is due 65 days before departure.

CANCELLATIONS: Full refund less \$25.00 handling fee per person will be made up to 91 days before departure.
